

THROUGH THIS WORK, WE ARE SPONSORING ORGANIZATIONS SUCH AS SINFONIETTA STRINGS, THE NASHUA PREVENTION COALITION, THE ONE GREATER NASHUA COALITION, AND LHIFA SC. AS THEIR FISCAL SPONSOR, UNITED WAY UNBURDENS THESE GROUPS OF THE RESPONSIBILITY TO FORM THEIR OWN 501C3 ORGANIZATIONS, FILE THEIR OWN 990'S, MANAGE PAYROLL, AND ATTAIN INSURANCE.
